### **Tutoring**

United Way of the Capital Area SOAR (Service Opportunities to Accelerate Reading), JSU Trio, and Peeples Middle School high-impact tutoring kicked off in January 2025 with **25 students**. Provine High School's High Impact Tutoring began in December 2024, serving **20 students** to enhance reading literacy.

### **Book Donations**

As a Reading is Fundamental Congressional Funds Awardee, United Way of the Capital Area donated over **19,000 books** to children across Hinds, Madison, and Rankin **at the Ranger Kid Club Book Giveaway**.

### HEALTH & WELLNESS

### "Healthy and Alive 2025"

United Way of the Capital Area and the Clinton YMCA launched the "Healthy and Alive in 2025" campaign on January 18th. The campaign motivates people to start the new year with a focus on developing a healthy mindset. About 10 vendors participated, offering health information and resources, as well as conducting blood pressure and glucose tests. United Way of the Capital Area invited the community to join a workout, speak with dietary professionals, and sample healthier meal options.



### **Youth Health Matters Symposium**

United Way of the Capital Area hosted **210** scholars from the tri-county area at our annual youth health symposium themed "Love Yourz". Seventeen vendors from the health industry distributed information specific to youth disparities and resource availability. Workshops covered topics on mental, physical, and emotional well-being.

In partnership with Blackburn Middle School and Jackson State University, our support provided fresh produce to the surrounding community through the annual farmers market, which showcased vegetables grown from the learning garden by the scholars of Blackburn Middle School.

### Volunteer Income Tax Assistance (VITA)

The United Way of the Capital Area offered FREE income tax preparation for low to moderate-income households in the Tri-county area. Volunteers completed 2320 Federal Returns and 2141 State Returns, thereby resulting in \$1,196,833.00 in savings for families.





## STATEWIDE INITIATIVES

United Way of the Capital Area's service area includes Madison, Hinds, and Rankin counties; however, UWCA funds initiatives and resources available to Mississippians across the entire state.

Community outreach aims to connect with and engage members of a specific community to address their needs and promote positive change. These programs often involve providing resources, education, and services, and may focus on areas like health, education, and social welfare.

Outreach acts as a vehicle for amplifying voices that are often unheard and mobilizing resources to those most in need. This aspect of outreach not only enacts change but also educates others about prevalent societal issues, fostering a more informed and empathetic community in the Hinds, Madison, and Rankin County areas.

# YOUTH UNITED AMBASSADORS PROGRAM

Youth United is an organization for high school student-centered volunteer opportunities. Youth United develops and nurtures the next generation of philanthropic leaders by creating unique leadership and community engagement opportunities for youth.

### **Volunteer Opportunities**

- Served as hosts during the Emerging Entrepreneurs and Leadership Symposium (EELS), the Youth Health Symposium, and Women's United Luncheon. Each event served an audience of 300 participants
- Served as hosts at Provine Career Fair, Lanier Health Fair, Callaway Reality Fair, and Forest Hill STEM event, reaching over 600 scholars total



### **United for ALICE**

United For ALICE is a driver of innovation, research, and action to improve life across the country for ALICE (Asset Limited, Income Constrained, Employed) and all. A new way to measure financial hardship called ALICE has provided a thorough and unbiased picture of the situation. United for ALICE presents a framework and language for stakeholders to reassess public and corporate policies and implement changes that improve the lives of ALICE and their communities.

### **What ALICE Does**

### 1. Produces Reports


We provide unbiased data that is replicable, easily updated regularly, and sensitive to local context. This data is accessible to corporations, nonprofits, and foundations throughout Mississippi.

### 2. Leads a Learning Community

United For ALICE facilitates a forum for sharing experiences, developing best practices, and building broader impact and fundraising strategies.

### 3. Inspires Action

The ultimate goal of this project is to stimulate action that will improve the financial stability of ALICE families and their communities.



### 2-1-1 Mississippi

**211 Mississippi** has been utilized in all 82 counties in Mississippi, serving as a vital resource for communities across the state. It offers free and confidential access to health, housing, food, disaster assistance, and more through a centralized platform.

This year, AARP and United Way have partnered to help people get access to AARP family caregiving resources through your local 211. Community members caring for loved ones and struggling to find support can call 211 to connect with a local 211 call specialist who can assist—free of charge—in finding AARP caregiving resources for issues like managing finances, transportation needs, and more.

Similarly, 211 was available to connect people with the United Way's Volunteer Income Tax Assistance (VITA) programs and local sites in the capital area.



# WOMEN UNITED EXCELLENCE AWARDS

United Way of the Capital Area annually brings together the community, stakeholders, and donors to honor women who have engaged in the work of United Way with excellence and tenacity. This year's Women's Leadership event drew nearly 300 attendees, including corporate partners and community leaders, who came together to celebrate impact and strengthen connections. The program began with an exciting silent auction, followed by a VIP reception, and culminated in an inspiring luncheon at the Westin Hotel.

This signature fundraiser generated \$76,588 in revenue — a 63% increase compared to the previous year. After covering event expenses, the fundraiser netted \$15,011 in support for our programs in health, education, and economic mobility. Beyond the financial return, the event engaged more than 80 donors and sponsors, strengthening relationships that fuel our mission year-round.
